Purpose

To provide you with advice on revisions to the consultation document *“Increasing the value from government investment in the New Zealand Screen Production Grant”* following feedback from the Social Wellbeing Committee (SWC) on 19 October 2022.

Executive Summary

In considering the consultation document *“Increasing value from government investment in the New Zealand Screen Production Grant”*, the SWC have asked International relations [redacted] You have asked for a revised version of the consultation document that makes clear International relations [redacted]

Giving effect to this request impacts on the presentation of Option 3 in the consultation document. In its current form, Option 3 would enable international productions to apply for up to a maximum 45 percent rebate on qualifying expenditure, as they would be eligible to apply for both a Repeat Activity Incentive and the stackable cultural content and creative talent incentives.

There are two approaches to giving effect to the request from SWC:

- **Amend Option 3** such that the base incentive remains International relations [redacted] but the stackable incentives differ International relations [redacted]
- **Remove Option 3** but include the stackable cultural content and creative talent incentives in Option 2 and include questions to seek feedback on the existing base criteria of each of the New Zealand and International grants.

We recommend the second approach Legal professional privilege [redacted]

This approach will still allow us to test options that seek more ambitious New Zealand content and business growth outcomes from domestic productions.

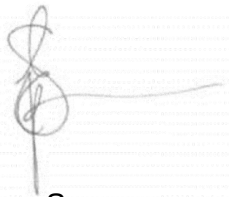

Background

1. In considering the consultation document *“Increasing value from government investment in the New Zealand Screen Production Grant”*, the Social Wellbeing Committee (SWC) ^{International re}
[REDACTED]
2. This does not impact Options 1 and 2 in the consultation document. Rather, it is in response to the proposal under Option 3 in the draft consultation document ^{International relations}
[REDACTED]
 - a. A 5 percent Repeat Activity Incentive; and
 - b. Up to 20 percent stackable incentives based on cultural content and creative talent criteria (in 5 percent increments).
3. You have asked for a revised version of the consultation document that makes clear that international productions will be eligible for a maximum 25 percent rebate. A (marked-up) revised version of the consultation document is attached at **Annex One**.

Proposed amendments

4. There are two approaches to revisions to the consultation document ^{International relations}
[REDACTED] (i.e. keeping incentive rates consistent with current settings):
 - a. ^{International relations}

 - b. **Remove Option 3**, consulting only on Options 1 and 2, but within this:
 - i. change the structure of the cultural content and creative talent test in Option 2 to be structured as a set of four stackable 5 percent components,
 - ii. add a question that invites feedback on how well the existing ‘base criteria’ for each of the NZSPG – New Zealand and the NZSPG – International align with and achieve the goals of that option.
5. We note that approach a. would also mean that New Zealand productions would no longer be proposed to be eligible for the Repeat Activity Incentive, meaning they remain only able to access a maximum rebate of 40 percent, compared to the 45 percent maximum in the version of Option 3 presented previously.

7. Under both approaches, we will also add to the consultation document standard language that notes that the final changes recommended will need to be consistent with our international trade obligations.

Advice

8. We recommend progressing with approach b as set out above – that is, to remove Option 3 and amend Option 2 of the consultation document. The revisions to the Consultation Document at Annex One have been made consistent with this recommendation.
9. We recommend this approach **Legal professional privilege**

Legal professional privilege This approach will still allow us to test options that seek more ambitious New Zealand content and business growth outcomes from domestic productions. We note that it might be possible to propose an alternative version of Option 3 **Legal professional privilege** but that this would require additional time and risks further delays to the start of consultation.

Rationale for the original Option 3

10. The rationale for including Option 3 in the consultation document was threefold:
 - a. Presenting the idea that international studios might produce strong New Zealand cultural content and / or significantly invest in New Zealand creative talent, and in doing so could increase the potential to take compelling New Zealand content to global audiences,
 - b. Testing the approach of creating one base incentive that consolidates and aligns criteria across all types of production, clarifying and simplifying the structure of the NZSPG across domestic, international and PDV productions, and through this potentially incentivising more ambitious, internationally connected New Zealand content and business growth.
 - c. Testing the approach of breaking down the cultural content and creative talent test into smaller stackable components to enable more targeted outcomes.
11. In amending option 3, you will retain the ability to test responses to the second and third of these points. In removing option 3, you will retain the ability to test responses to the third point, and we will seek feedback in other ways on where we might alter NZSPG – New Zealand criteria to better incentivise ambitious New Zealand content and business growth.

16. Subject to your agreement, your Offices will re-submit the consultation document in time for consideration by Cabinet on Tuesday 25 October 2022.
